

Sub: Affairs of Majlis-e-Rifahul Muslimeen, Muslim Boys' and Girls Orphanage, Mysore, under Wakfs.

Ref: Letter No.MBO/129/09-10, dated 23.2.2010 of Secretary, Muslim Boys' Orphanage, Mysore.

As per the letter under reference, this is to inform that consequent upon the enactment of Wakf Act, 1954 the Government of Karnataka appointed a Survey Commissioner for the survey of Mosque, Eidghahs, Ashoorkhanas, Dargahs, Makans, Charitable Institutions, like Orphanages, etc., in the State. After a comprehensive Survey the Survey Commissioner identified such Institutions and notified the same in the Government Gazette. So, the list of such Institutions of Mysore District was published in Mysore Gazette bearing No.MWB/19(2)/1965, dated 1.4.1965 notifying them as the Wakf Institutions alongwith their allied properties. As such the Majlis-e-Rifahul Muslimeen, Muslim Girls' Orphanage, Muslim Boys' Orphanage and Sawarline Mosque are Wakf Institutions, notified under Sl.No.62, 63 & 64 of the said Gazette. All the Wakf Institutions in the state are administered and managed by the Karnataka State Board of Wakfs, as per the provisions of Wakf Act, 1995 which is a new enactment after the Wakf Act, 1954 and once a Institution/property is registered under the Wakfs, its administration and management lies with the Karnataka State Board of Wakfs irrespective of its earlier registration under any Act. This is for kind information.

PROCEEDINGS OF THE KARNATAKA STATE BOARD OF AUQAF, BENGALURU

Sub:- Extension of term of the Managing committee for the Management of Majilis- E-Rifahul Muslimeen Muslim Boy's & Girl's Orphanage, New Sayyaji Road, Mandi Mohalla, Mysuru.

PREAMBLE:

The Masjilis-e-Rifahul Muslimeen, Muslim Boy's and Girls Orphanage, New Sayyaji Rao Road, Mandi Mohalla, Mysuru, is a Gazette Notified Waqf Institution, vide Gazette Notification No. MWB/19(2) /1965, dated: 01.04.1965 at SL.No. 62,63 & 64, Masjilis-e-Rifahul Muslimeen, Muslim Girls Orphanage Sunni, Sawar Line Mosque, Sunni, Muslim Boys Orphanage are shown separately under SL.No. 62, 63 & 64 all these Waqf Institutions are under common and single management since its notification and the managing committee is constituted as Masjilis-e-Rifahul Muslimeen, Muslim Boys & Girls Orphanage.

The Board vide order No. KTW/CMC/03/MYE/1990-91, dated:23.04.2021 has constituted the managing committee for a period of three [03] years or until further orders whichever is earlier for the management of the Waqf Institution, and the said term has expired.

Further, the Waqf Officer, DWAC, Mysuru vide letter dated: 24.06.2024 has requested for extension of term of the managing committee for a period of one [01] year as the managing committee has taken up developmental works and to get the Form-42 approved by the Board.

The Matter was placed before 357th Board meeting held on 01.07.2024 vide subject No. 9[01] and the Board has resolved as follow.

" The above subject is taken up for discussion after due deliberation and after gathering the information from the institution and considering the development activities, the Board is of the opinion to extend the term of the committee for further period of one [01]years with a direction to adopt the Model Scheme of Administration and get it approved by the Board within six [06] months of the date of this order and after that action shall be taken to intall a regular committee. If the regular committee is approved as per the approved scheme of Administration the term of the extension of the present committee shall end".

In view of the facts mentioned in the preamble and in exercise of the powers conferred under the provisions of the Waqf Act, 1995 & Karnataka Waqf Rules 2017, the Karnataka State Board of Auqaf, hereby extends the term of committee for further period of one [01]year with a direction to adopt the Model Scheme of Administration and get it approved by the Board within six [06] months of the date of this order and after that action shall be taken to install a regular committee. If the regular committee is approved as per the approved scheme of Administration the term of the extension of the present committee shall end the approval for extension of term of the Managing Committee is for the management of Masjilis-e-Rifahul Muslimeen, Muslim Boy's and Girls Orphanage, New Sayyaji Rao Road, Mandi Mohalla, Mysuru District.

Sub: Constitution of Managing Committee for the Majlis-E-Rifahul Muslimeen, Muslim Boy's & Girl's Orphanage, New Sayyaji Road, Mandi Mohalla, Mysuru.

PREAMBLE:

The Majlis-e-Rifahul Muslimeen, Muslim Boys & Girls Orphanage, New Sayyaji Rao Road, Mandi Mohalla, Mysuru, is a Gazette Notified Waqf Institution, vide Gazette Notification.MWB/19(2)/1965 dated: 01-04-1965 at Sl.No.62, 63 & 64. Majlis-e-Rifahul Muslimeen, Muslim Girls Orphanage, Sunni, Sawar Line Mosque, Sunni, Muslim Boys Orphanage are shown separately under Sl.No.62, 63 & 64, all these Waqf Institutions are under common and single management since its notification and the managing committee is constituted as Majlis-e-Rifahul Muslimeen, Muslim Boys & Girls Orphanage.

The Board had constituted a managing committee vide Order No. KSBA/CMC/63/MYE/1990-91, dated 12.3.2014 & 12.3.2018 and the term of the committee has expired.

Whereas, the Waqf Officer, Mysuru District, vide report dated: 20.01.2021 has submitted that, Sri. Tanveer Sait, Hon'ble MLA and Member, Karnataka State Board of Auqaf is the President of the said Waqf Institutions. As verified the existing managing committee has done a good work with regard to the development of the said Waqf & its Properties which were lying idle in prime locations worth crores. With the vision of Sri Tanveer Sait and dedicated service of the existing managing committee, both the Orphanages found lot of revolutionary changes with regard to development of Waqf properties and welfare of the inmates. As of now the orphanages have three major projects on hand, like, construction of Hostel for boys, construction of working women hostel and extension of building of Huda Public School. All the three projects are under progress, which needs to be completed, as stated by the Secretary of the Waqf Institutions during the inspection of projects by the Waqf Officer, District Waqf Advisory Committee, Mysuru. Apart from these there are other commercial developmental works to be taken up on other major Waqf Properties of these Waqf Institutions. Further states that, the existing managing committee has done a appreciable efforts of safeguarding the properties of the Waqf Institution and developing them and providing of amenities as per the requirement of inmates and also the Waqf has 3 major projects on hand as narrated above to be completed and several other properties which have commercial viability and required to be developed in a planned and phased manner.

The Waqf Officer, DWAC, Mysuru has requested to constitute a managing committee of said Waqf institution, of the following twenty one (21) members, for a period of 3 years keeping in view the development of the Waqf Institution, with a direction to get approve the Form-42 of the Waqf.

- c) The Managing Committee should pay the Waqf Contribution upto date as per sec 72 of the Waqf Act.
- d) The Managing Committee should submit the audit report for the last three years as per Sec 47 of the Waqf Act.
- e) The Managing Committee should submit the property details along with additional properties, if any.
- f) The Managing Committee should submit the details about lease / rentals along with agreements.
- g) The Managing Committee should intimate the cases if any pending in different Courts, litigations, if any.
- h) The Managing Committee should send a report about the performance of the Previous / continued committee.
- i) The Managing committee should submit the Budget of the Institution within the stipulated time (Sec 44).
- j) No member of the committee will be either a tenant or lease holder of the Waqf.
- k) The Managing Committee members shall not have been undischarged/convicted any criminal offence.
- l) It is found that the wrong information has been provided the orders of the Managing Committee will be liable to be cancelled without any notice.
- m) It it is subsequently found that any of the Office bearers or members of the Managing Committee are facing enquiry Under Section 52, 54 or PP Act, their names will be deleted without notice.
- n) All office bearers & members of Managing Committee shall take a oath as Per Government Circular No.MWD/181/WES/2017 Dated: 12-12-2017 and a copy of the same to be furnished to the concerned D.W.A.C.
- o) The Managing Committee should get approved the Scheme of Administration within (03) three months from the Board.
