**SCOPE :**

- 4.3 To takeover all such existing educational institutions and ancillary centers for promoting the main objects of the TRUST;
- 4.4 To acquire land, buildings and such other assets for achieving the objects of the Trust BY Purchase, lease ,bequeaths, gifts etc. and to also to dispose them off;
- 4.5 To undertake any other activities conducive to the promotion of the main objectives mentioned hereinabove.

**5. INCOME, FUNDS AND PROPERTIES:**

- 5.1 **APPLICATION OF INCOME:** The funds and the income of the trust shall Be solely utilized for the achievement of the objects and no portion of it shall be utilized for payment to the Trustees or their relatives or any other persons contemplated under Section 13(1) © of the IT Act by way of profit, interest, dividend etc, whether directly or indirectly. The Trust formed shall be irrevocable.
- 5.2 The benefits of the Trust shall be open to all irrespective of caste, creed or religion.
- 5.3 The funds of the Trust shall consist of the Corpus, Donations received both inside and outside India, income and all accumulations and accretions and additions thereto and also movable and immovable properties.
- 5.4 **INVESTMENTS :** The funds of the Trust Shall be invested in modes specified under the provisions of Section 13(1) (d) read with section 11(5) of the IT Act as amended from time to time.



- 5.5 **AMENDMENTS** : No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of Sections 2(15), 11, 12, 13 and 80G of the IT Act from time to time, Further, No amendments shall be carried out without the prior approval of the Commissioner of income Tax.
- 5.6 **DISSOLUTION** : In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees or their relatives, but the same shall be transferred to another Trust or institution whose objects are similar to those of this Trust and which enjoys recognition under Section 80G of IT Act, as amended from time to time.

### 6. ADMINISTRATION :

- 6.1 The Trust shall be administered by a Board of Trustees ( the Board in Short) comprising of all the Trustees. The strength the Board shall not be less than eleven and more than seventeen.
- 6.2 The term of the Trustees including the founder Trustees initially shall be for a period of 5 years from date of their appointment or till they retire or resign or death or expelled due to such activities conducted by them against of the Trust, whichever is earlier . Thereafter they may be, re-appointed by the board for a further period of five years and so on That is to say , the trustees shall hold office of the Trust for a period of five years from the date of their appointment. It may be renewed on expiry of the said term.
- 6.3 As per the original Trust Deed, out of the Thirteen Trustees who authored the said Deed, Two have already resigned and their resignations accepted and have been





relieved off their responsibilities. The term of the remaining eleven Trustees shall end arise. The term of the Co-opted Trustees shall also be five years from the date co-option .Once they are Co-opted as trustees, their rights & responsibilities. Shall be in par with the remaining Trustees.

- 6.4 The Board shall elect from amongst themselves the following office bearers for the conduct day to day affairs of the Trust. They shall hold office till such time as decided by the Board in their meeting or till such time they resign from the Trust. **The office bearers shall be.**  
1) President 2) Vice president 3) Secretary 4) Joint Secretary 5) Treasurer
- 6.5 The term of the office bearers Co-terminus with the period of office of Trusteeship of five years. They are eligible for reappointment.
- 6.6 The Board may constitute a Management Committee( MC in short) Comprising of the Office bearers and heads of Institutions which it is running as when the need arises, as required by the Karnataka Education Act, 1983. The period of the MC shall be for a period of one academic year.
- 6.7 Any Trustee may resign on personal reason with prior intimation. Any Trustee may be removed by two-thirds majority of Board, if it is found that such Trustee has become incapacitated physically, mentally of legally.
- 6.8 UNLESS OTHERWISE DIRECTED BY THE Board. The President shall be the Chief Executive of the Trust and has the general conduct and charge of all the affairs and activities of the Trust He shall preside over all such meetings of Trust and has authority to make decisions not conflicting with the policies and objectives of Trust.

6.12 UNLESS OTHERWISE DIRECTED BY THE BOARD, the Treasurer shall also be in charge of funds and properties of the Trust, He shall exercise general supervision and guidance as to the financial transactions of the Trust including receipts and disbursements of funds and maintain accounts, he shall get the accounts audited every year and submit the same before the Board.

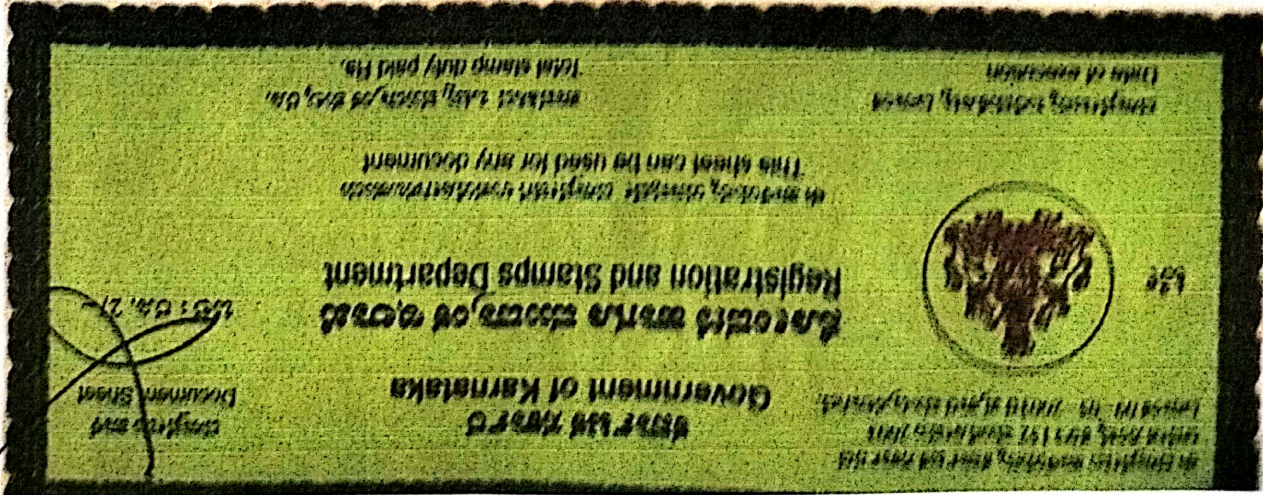
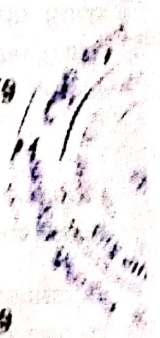
